2.0 The Punjab Technical University is also pleased to further issue the following criteria for making the admissions to B.Pharmacy and Pharma.D courses:

A <u>ELIGIBLITY CRITERIA (Educational and Resident status) for admission:</u>

I. B. Pharmacy Course

All those candidates who have passed the 10+2 examination from a board recognized or established by Central/State Government through a legislation with Physics and Chemistry as compulsory subject along with one of the Mathematics/Chemistry/ Biotechnology/ Biology shall eligible to apply.

OR

All those candidates who have passed Diploma Pharmacy from an institute affiliated to Punjab State Board of Technical Education & Industrial Training / Punjabi University, Patiala or any other University or any State Board of Technical Education provided that the diploma or the institute duly approved by the PCI /PTU.

II. Pharma.D course

The minimum qualification for admission to Pharma.D course shall be as follows:

- A pass in 10+2 examination from a board recognized or established by Central/State Government through a legislation with Physics and Chemistry as compulsory subjects along with one of the following subjects:
 - Mathematics or Biology
- A pass in D.Pharm course from an institution approved by the Pharmacy council of India under section 12 of The Pharmacy Act.
- iii) Candidates shall be admitted to 4 year B.Pharmacy course and 6 year Pharma.D course on the basis of inter-se-merit in the qualifying examination mentioned above.

GENERAL ELIGIBILITY CRITERIA FOR ADMISSION TO B. PHARMACY/PHARMA D. COURSE:

(i) Apart from the basic educational qualifications prescribed above, the general eligibility criteria shall be as contained in Punjab Government, Department of Technical Education & Industrial Training, Punjab Memo No. 35/44/95-1T(2)/978 dated 21st March, 2003, which is annexed to this notification, This communication shall be treated as a part and parcel of this notification, for all purposes, and communication.

Exemption under above Para

(ii) Children/wards/dependent (whose parent are not alive) of all those regular Punjab Government employees, members of All India Service borne on Punjab cadre, Serving Judges and the employees of the Punjab and Haryana High Court, employees of Boards/Corporations/ Statutory Bodies established by an act of the state of Punjab who that is on or before 1st January, 2014 and their children/wards /dependents may have done 10+1 and/or 10+2 outside Punjab.

RESERVATION:

- The reservation of seats shall be as per Punjab Government, Department of Technical Education and Industrial Training Memo. No. 13 / 2/ 05 -1TE2/1987 dated 2nd July, 2013, which is attached (1)
- The attention of the applicants desirous of claiming reservation under any category (ii) whatsoever is especially drawn to the condition and stipulation that only the certificates that have been produced at time of admission shall be considered. The candidates are accordingly advised, in their own interest, to get the requisite certificates issued well before the date of admission, otherwise, claim for reservation shall be summarily rejected.
- Candidates are required to claim reservation at the time of registering for online counselling. If no reservation is claimed the candidates shall be treated and considered as a "General Candidate".
- The College shall make a provision in the online application form for a candidate to indicate the (iv) category, if any, under which he/she is seeking reservation. There shall also be a provision to indicate the sub-category of the category, if any, under which reservation is being sought, so that inter se gradation can be facilitated. These sub-categories have been elucidated in the Punjab Government, Department of Technical Education and Industrial Training Memo No. 13 / 2/ 05 -1TE2/1987 dated 2nd July, 2013, which is attached as Annexure. Punjab Government may also set up a committee to effect inter se gradation of candidates claiming reservation under certain categories, as indicated in the aforesaid memo dated 2nd July, 2013.
- A candidate shall be eligible to make claim for reservation in one reserved category only. (v) However, the procedure for counselling shall be as per Punjab Government, Welfare Department (Reservation Cell) Memo. No. 7/21/2004 - RS1 / 1674 - 1677 dated 20th Dec., 2004,

GENERAL CONDITIONS: D.

- Applications shall be invited from the aspirant candidates through an advertisement at least in two leading newspapers (one in English and one in Punjabi Language) for admissions.
- Rank shall be prepared on the merit basis as per the criteria mentioned above,
- The seat matrix shall be uploaded on the college website as per the existing Punjab Government reservation policy as per Punjab Government, Department of Technical Education and Industrial Training Memo, No. 13 / 2/ 05 1TE2/1987 dated 2nd July, 2013 available on PTU website.
- Each college shall conduct online or manual counseling. The ment list and seat allotment shall be uploaded on the college website.
- After declaration of result, seven days time shall be given to deposit the fee.
- There shall be no profiteering or charging or any capitation fee, directly or indirectly by the college, Miscellaneous charges like Admission Fee, Security, Student Fund shall be charged as per University / Punjab Govt.
- If any candidate is getting seat in general category as to his / her higher rank in merit, but the candidates belongs to reserve category and he she has filled his category as reserve, he i she shall be given seat in general category and he will be eligible for all benefits of reserve category like Post-matric Scholarship Scheme, fee walver scheme etc.
- in case a student surrenders his / her seat before 8th August i.e. before the 7 days of last date of admission (15th August, 2014), through an application to the college, the college will refund his / her full fee within 7 days after deducting Rs. 1000/- only. The student shall also forward a scanned copy of application submitted to the college at email admissioncell.ptu@gmail.com
- If a student leave after joining the course and if the seat subsequently falling vacant gets filled by another candidate by the last date of admission, the Institution must return the fees collected with proportionate deduction of monthly fee and proportionate hostel rent, where applicable.
- Whole process of admission shall be clearly available on the college website and shall be transparent and inform to Punjab Technical University before start of admission process.
- 11 In case any complaint is received in this regards against any college, the whole responsibility shall be laid on the college and college shall be liable to pay the compensation to the concerned student(s).
- University reserves the right to withdraw the power at any time delegated to the colleges for making admission at their own level without assigning any reason.
- 13 The process of admission can be started immediately after the issuance of notification,
- 14 Any college can fix the minimum eligibility for admission at their own level and it should be clearly displayed on the website of the college and communicated to the University.
- No college will retain the original certificates of the students at their college. The original certificates will only be submitted at the time of eligibility check.

16 The college shall comply strictly with all the rules and regulations formulated/laid down by the university or any competent authority regarding the admissions and if the college fails to comply with the rules and regulations, then the university reserves the right to take strict action against the college as per law.

E. OVER-RIDING PROVISION:

Nothing in this notification shall be operative in so far as it is inconsistent with the law of the land as laid down in the judgement of the honourable Supreme Court of India in the case of TMA Pai Foundation and others vs. State of Karnataka and others (2002) 8SCC 481:AIR 2003 SC 355). Any such inconsistency may be brought to the notice of the Government of Punjab, clearly highlighting the inconsistency, for immediate rectification.
